## **Call for Speakers**

### INTRODUCTION

The 8<sup>th</sup> World Summit on Mediation with Age-Related Issues will be held from May 2 to May 4, 2016. It will be co-hosted by Elder Mediation Austria in partnership with the Elder Mediation International Network (EMIN). Previous Summits have been held in Scotland, Switzerland, the United States, Ireland, Canada and Australia.

The Summit will host a selection of national and international speakers on elder mediation and associated topics and the conveners invite practitioners, specialists and individuals from multi-disciplinary professions to submit an expression of interest in presenting at the summit.

### SUMMIT AIMS

In recent years the international summits have become a forum for experts in the growing field of elder mediation. The conference provides the opportunity for exchange of knowledge and experience on a professional and interdisciplinary basis.

### SUMMIT GOALS

1. To help raise awareness of elder mediation and its important role in supporting and/or re-establishing self-determination, encouraging participation in decision-making and ensuring equal opportunities for older people

2. To establish and further develop the knowledge base of elder mediators and other decision-makers in age-related professions
3. To enhance the development of elder mediator competence through the contributions of experts from science, research and practice
4. To exchange opinions and experiences, discuss current issues and share new insights regarding the issues and conflicts faced by older people in their personal, family and work environments
5. To generate ideas and concepts for the further development of elder mediation
6. To provide a platform for networking and to promote and create strategic partnerships

## CALL FOR SPEAKERS

The Summit Steering Committee invites participants to submit an abstract of their proposed conference paper/presentation.

Presentation abstracts and conference papers should be well written, relevant and engaging. Abstracts should briefly describe the title and content of the presentation. Research papers should be descriptive and detailed. Authors may describe their contribution to elder mediation research, their practice experience, highlight ethical concerns or discuss issues of relevance to the field.

In particular, we welcome contributions on the following topics:

### **Elder mediation in general**

- Ideals and principles of (elder) mediation
- Special features in process design, methodology, communication skills and interventions with special attention to conflict situations
- Roles and attitudes of elder mediators, self-reflexibility
- Consumers' view of elder mediation
- Specific approaches to conflict management and prevention involving older people
- Dealing with ageism and age discrimination in elder mediations
- Elder Mediation, intergenerational violence, neglect and self-neglect

### **Age and Family - Family and Age**

- Dealing with transitions in familial roles and responsibilities in the elder mediation
- Dealing with issues emerging from the past in elder mediation

### **Age and occupation - occupation and age**

- Generational and age related conflicts at work
- Elder Mediation and the transition to retirement
- Elder Mediation and Corporate Social Responsibility (CSR)

### **Age and age related health issues**

- The older person's perspective in the elder mediation process
- Elder Mediation, long-term care and support in institutional and family care
- Difficult decisions and dilemmas surrounding medical treatments and dying
- Elder mediation as a support for caregivers

### **Elder mediation for conflict resolution at the end of life**

- Conflicts around dying and death
- Managing grief and loss in (elder) mediation
